Quarter Two Performance Evaluation

Strategic Policy Initiatives

The Office of Colorado’s Child Protection Ombudsman (CPO) created its strategic policy initiatives after a thorough analysis by the Ombudsman revealed areas where the CPO could improve by utilizing impactful strategies. Those strategies include four goals comprised of broad, long-term strategies to make the CPO a more efficient and effective agency. Each of those goals encompass specific strategies that will drive the CPO forward. In order to ensure it is working toward achieving those strategies, the CPO has set specific performance measures to track and analyze its progress.

The CPO staff met on September 14, 2016 to discuss its [Quarter One Performance Evaluation](#). That evaluation was submitted on October 1, 2016. Staff met again on December 13, 2016 to discuss its strategic policy initiatives and any progress or setbacks in achieving those initiatives. That information was used to create the CPO’s Quarter Two Evaluation.

Goal One: Establish an efficient office to ensure seamless delivery of services to the public.

STRATEGY ONE: Build physical infrastructure of the CPO

Performance Measure – Develop a safe and appropriate work space with allotment for future growth.

Quarter ONE: The CPO’s new office space was completed at the end of July 2016 and staff moved into the space on August 2. Since moving operations into the space, the CPO has assessed the space and any needs. Currently, the space will accommodate two additional staff members and two interns. The Ombudsman has reviewed the available job descriptions and is in the process of drafting new descriptions and evaluations for staff.</p>	<p>Quarter Two: The State Court Administrator’s Office has reviewed the CPO’s personnel rules and a copy of those rules has been provided to all CPO employees. CPO employees have signed a copy of the new rules, as well as an updated confidentiality agreement. In November, all CPO job descriptions were updated and individual staff evaluations were held. Additionally, a filing system has been implemented for CPO personnel information.</p>

STRATEGY THREE: Establish Board structure and operating policies

<p>Quarter One: In completing its 2015-2016 Annual Report, the CPO reviewed 206 recommendations and developed a way to track and analyze the types of recommendations it makes.</p> <p>Currently, the CPO is conducting outreach to develop the best methods in which to deliver information about recommendations to the public and how to track whether agencies address recommendations.</p>	<p>Quarter Two: The CPO has continued assessing how to best track and publish its recommendations to the public and stakeholders. As the assessment continues, the CPO will focus on obtaining stakeholder input and adhering to state and federal confidentiality laws. But progress on finalizing the policies has been significantly delayed due to a lack of resources. The CPO has realized that without additional staff such delays will continue. In November, the CPO submitted a request to the Joint Budget Committee asking for additional staff positions. Details about the CPO's request may be found HERE.</p>

STRATEGY TWO: Create communication policies in accordance with state law

Performance Measure – Develop procedures to effectively respond to Colorado Open Records Act Requests and educate the staff on compliance with CORA.

Key Metrics

- Write and implement procedures.
- Collaborate with the Colorado Attorney General’s office to ensure the CPO’s policies meet statutory requirements and align with best practice.
- Develop online information (CORA) request form for citizens and media outlets.
- Train CPO staff on CORA and office policies.

Status: COMPLETED in Quarter TWO

Quarter One: The CPO has started working with the Attorney General’s office to ensure its policies align with statute. A draft of the CPO’s policies for responding to CORA requests is being finalized. Information about the CPO’s procedures in handling information requests have been posted to the CPO’s website. Staff have received training on how to handle information requests. A formal online request form will also be created and posted to the website. The policies will be completed and published in the CPO’s Operations Manual in January 2017.

Quarter Two: The CPO worked with the Attorney General’s office during Quarter Two to finalize its policies and procedures for responding to CORA requests. Citizens may access the policies on the CPO’s website, where they also have access to instructions on how to file a CORA request.

Performance Measure – Develop procedures for document retention for internal records and confidential case records.

Goal Three: Institute outreach and communication plans to educate and advise the public and stakeholders on trends and recommendations to improve the child protection system.

STRATEGY ONE: Develop a public policy strategy

Performance Measure – Create a short-term public policy plan.

Key Metrics

- Identify systemic policy concerns and prioritize any necessary investigations.
- Create a strategy and calendar for the 2017 legislative session to provide education to legislators when requested to do so.
- Create a strategy and calendar for speaking at relevant conferences.

Status: ONGOING

Quarter One: The CPO has identified eight systemic policy issues within the child protection system. Those issues were prioritized and the Ombudsman has assigned appropriate staff members to handle specific reviews. Since the start of the current fiscal year, the Ombudsman has presented at five conferences. In August, the CPO completed a day-long outreach initiative in the Seventh Judicial District. Currently, the CPO staff are planning a reception for legislators. As the 2017 legislative session approaches, CPO will continue to assess how to best serve as a resource for lawmakers and stakeholders.

Quarter Two: During Quarter Two, the CPO started researching three of the systemic policy issues it identified within the child protection system. Staffing limitations, however, have delayed substantial progress on those three cases, as well as prevented the CPO from initiating research on others. In November, the CPO submitted a request to the Joint Budget Committee asking for additional staff positions. Details about the CPO’s request may be found [HERE](#).

With the 2017 legislative session approaching, the CPO has shifted some focus to legislative outreach and preparation. These efforts include hosting an open house for legislators and stakeholders in January, creating information packets for legislators and updating the CPO’s legislative reference book.

The Ombudsman and Deputy Ombudsman have continued to present at relevant speaking engagements.

Performance Measure – Create a long-term public policy plan.

Key Metrics

- Research and select an annual systemic policy initiative for the CPO to address.
- Identify key opportunities to educate legislators on child protection issues.
- Identify key engagement opportunities with the executive and judicial branches.

<p>Quarter One: CPO staff have started collecting information on multiple systemic complaints, including issues within the Colorado Division of Youth Corrections, the Foster Care Bill of Rights and adoption subsidies. The Ombudsman has presented four information sessions to judicial officers since the start of the fiscal year. Moving forward, the CPO will continue to assess how to best engage and serve the executive, legislative and judicial branches.</p>	<p>Quarter Two: During Quarter Two, the CPO identified three systemic policy initiative to address, including adoption subsidies and accessing behavioral health services for children diagnosed with severe mental health and disability. Research is ongoing and the CPO has dedicated several hours to informational meetings with professionals involved in both cases. The CPO is no longer pursuing research concerning the Foster Care Bill of Rights.</p> <p>In an effort to find innovative and effective methods for investigating systemic issues within the child protection system, the CPO has started developing new programing. While the program is in its infant stage, the CPO is researching new ways to bring agencies together to resolve issues hindering the delivery of services to children within the child protection system.</p>

Goal Four: Increase staff to meet the growing demand for services.

STRATEGY ONE: Analyze the CPO’s needs to meet the demand for outreach and education and comply with statutory mandates

Performance Measure – Assess any additional funding that may be needed to bolster the part-time position of Communications and Policy Director.

Key Metrics

- Evaluate the need for a full-time Communications and Policy Director by monitoring responses to outreach efforts and requests from citizens and stakeholders for information.
- If necessary, present funding request to the Joint Budget Committee.

Status: ONGOING

Quarter ONE: Since joining the CPO in July, the Communications and Policy Director has helped complete the annual report, all reports required under the SMART Act, handled multiple media requests as well as prepared staff members for interviews and provided support and outreach at five conferences. The CPO, however, is currently assessing the additional funds and hours needed to complete additional tasks, such as the CPO’s first quarterly report, assisting in systemic reviews and drafting policies for the CPO Operations Manual.

Quarter TWO: The CPO submitted its funding request – including a request to make the position full-time – to the Joint Budget Committee in November. The Ombudsman presented at the JBC in December. Details about the CPO’s request may be found [HERE](#).

Key Metrics

- If necessary, present funding request to the Joint Budget Committee.

Quarter ONE: The CPO is assessing the workload of its current Investigator to help determine the need for additional staff. The number of complaints the CPO is receiving continues to increase, which in turn is increasing the caseload of its investigator. Also, since the start of Fiscal Year 2016-2017, the CPO has received complaints
